## Dear Animal Lover,

Ever since Pet Pantry opened in 2012, we haven't been able to fulfill one of our biggest dreams: finding more forever homes for dogs. We cannot keep dogs overnight at our Millersville Road facility. Any stray or surrendered pup must go out the same day to a foster family. We just don't have the space, staff, or volunteers to handle those turnarounds on a regular basis.

That is about to change—for the better!

We have found the perfect place for Pet Pantry to expand. The building is a former pet grooming and kennel business, is zoned to allow dogs overnight, and is just a quarter mile away on Columbia Avenue! Lancaster will have a new place to go to rescue a dog.

The building has sufficient space for us to dramatically grow our Trap-Neuter-Vaccinate-Return (TNVR) program for Lancaster's feral cat population. We can even provide housing for veterinarians who volunteer their services to treat these unadoptable felines, reducing their population. It is literally a perfect fit for dogs, for cats, for future dog adoptions, and for Pet Pantry.

Creating our second home is possible only through charitable donations from people who love animals. We need your help to transform this ideal location into a dog adoption and feral cat surgery center. Combined with our existing facility, it will enable Pet Pantry to provide all the services Lancaster County's pets and feral cats deserve. Please join us to save more lives and find more pups their forever homes.

# About Pet Pantry

Pet Pantry started in our co-founder's living room, where she collected dog and cat food to distribute to families experiencing economic hardship. From helping people be able to keep their beloved pets to providing life-saving veterinary care for rescued dogs and cats, Pet Pantry has grown to become Lancaster County's favorite and most successful resource for animals in need.

## FEED

We provide emergency and longer-term pet food assistance to those in need to ensure pets remain happy, healthy, and safe in their homes and with their loving families.

## FIX

We help reduce pet overpopulation concerns through lower-cost spay/neuter procedures and our feral cat Trap-Neuter-Vaccinate-Return (TNVR) program. We work to remove barriers to accessing exceptional veterinary care.

## RESCUE

We work to find loving forever homes for animals in need. We accept stray or surrendered animals if we can accommodate them in our facility or in a caring foster home. We are a No Kill Shelter.

# DIFFERENCE

## Lancaster Born and Raised

We started here and we serve here. Every dollar donated helps local animals only, not a large umbrella organization. We are fully invested in this community.







## *No-Kill Shelter*

We mean that. We never euthanize an animal because no one has adopted it yet or we need the space.

## *Limited-Admission Shelter*

We accept an animal only if we have the capacity to care for it properly. That is the promise we make to every animal.

## *Fear Free<sup>®</sup> Certified*

Every staff member and volunteer is trained to prevent and alleviate fear, anxiety, and stress in pets. Our medical director has undergone additional training to ensure our facility and procedures do not frighten our animals unnecessarily.

## *Educating Responsible Owners*

We educate families who adopt from Pet Pantry about taking care of their animals. We provide access to licenses, vaccinations, food, and other essentials, and we check in after the adoption to make sure everyone is adjusting well.

## *Returns Accepted*

If a family cannot keep a pet they have adopted from us for any reason, we require that they return the animal to us. We will find another forever home for it.



## *Focused on the Animals*

We show our love for animals by listening and responding to their unspoken needs. We believe that every animal is worthy and deserves a loving home.





# THE PERFECT PLACE

We waited eight years for this building to become available. Located just **a quarter mile away** at **2120 Columbia Avenue**, it's the ideal location and size for Pet Pantry's second home. The short distance between the two buildings will make it easy for staff and volunteers to work at both. Even the "back way" is less than half a mile.

## *Properly Zoned and Licensed*

We have wanted this specific property because it has already been zoned and licensed to have dog kennels on the premises—a rare combination in a populated area. Such licenses are extremely challenging to obtain for a new location, and existing ones cannot be moved elsewhere. The property's General Commercial zoning makes veterinary care an allowed use.

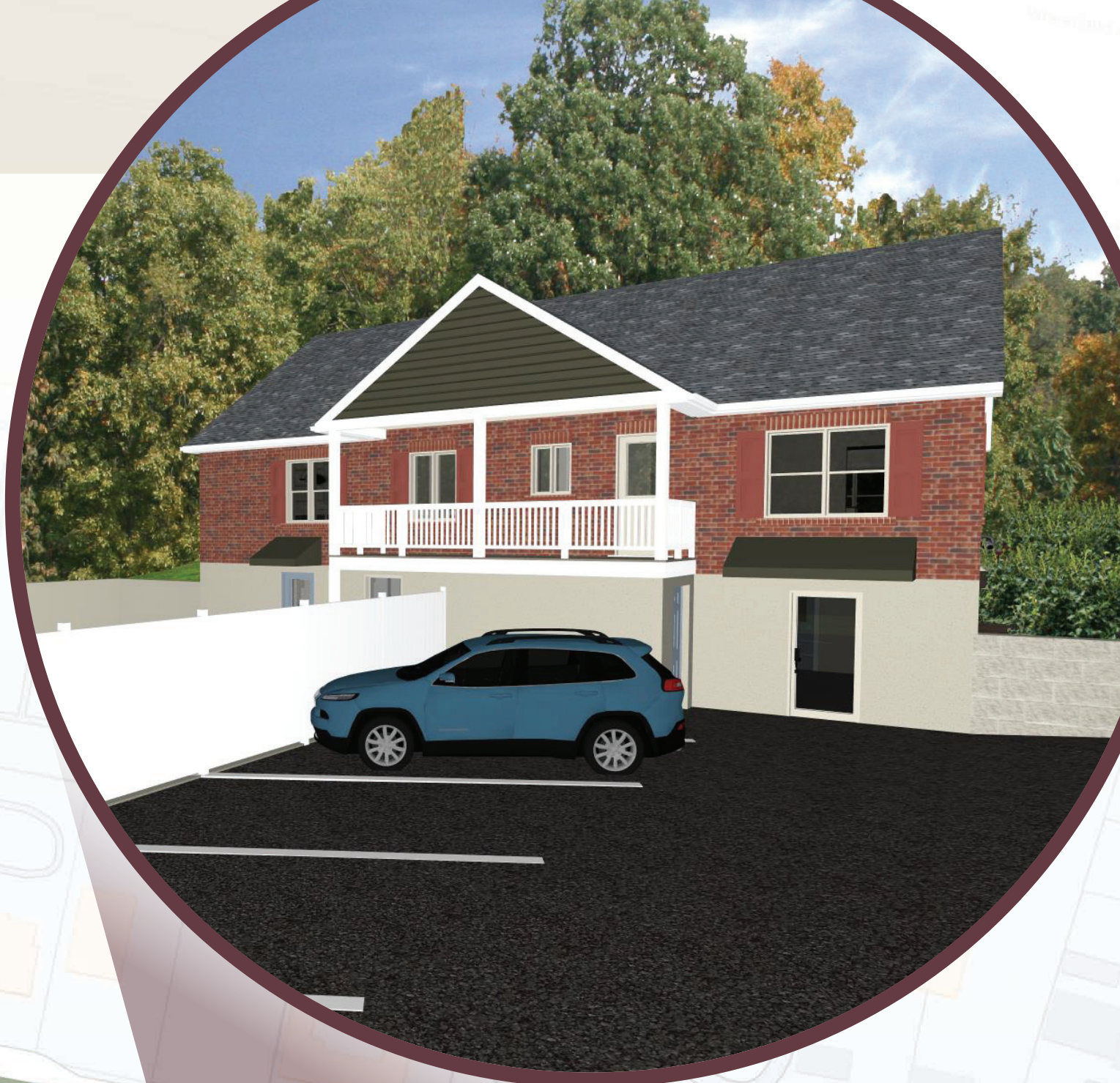

# DOG ADOPTION CENTER

In the new building, finding forever homes for dogs will become one of Pet Pantry's core services. We will finally have the capacity to shelter dogs until they can be adopted.

## *Temporary Quarters*

Kennels in the lower level will house dogs until we can place them with a foster family – or their forever one. Opaque walls between each kennel will prevent the dogs from seeing one another constantly, thereby reducing their stress level. Sliding doors will enable adjacent kennels to be connected, creating a larger space for a dog when possible.

## *Vet Checked and Groomed*

Our veterinarians will check each new dog in the lower-level exam room and provide any needed treatments or procedures. The dog can be quarantined in a separate room if needed to ensure it does not spread disease to the others. Staff and volunteers will pamper each new arrival with tender loving care, including a bath.

## *A Caring Transition for Strays and Surrenders*

A small lobby off the rear entrance will serve people dropping off a stray or forced into the heartbreaking decision to surrender their pet. The warm environment will reassure them that their dog will be well taken care of.

## *Meeting Their Forever Family*

The main floor lobby will provide a homelike atmosphere for our dogs to meet potential adopters. The fenced backyard will be used as a neutral spot for introducing a dog to its new family's existing pets.

# A SURGERY CENTER FOR FERAL CATS

Renovations to the main level will enable us to dramatically increase the number of feral cats we treat. Trap, Neuter, Vaccinate, Return (TNVR) is the only proven effective method of helping to stabilize feral cat populations.

## What is a Feral Cat?

Also known as strays or community cats, these animals lead short, hard lives fighting starvation, disease, worms, extreme heat and cold, fleas, injuries, and human cruelty. They tend to live in colonies. They are fearful of people and cannot be turned into adoptable pets. Addressing these animals' needs has been one of our core services since 2013.

## Protecting Adoptable Cats

Feral cats will be treated only at the new facility on Columbia Avenue. Keeping them in a separate building will prevent any accidental transmission of diseases or pests to cats awaiting adoption at our current home.

## How TNVR Works

Community members humanely trap the cats and bring them to us. Our veterinarians spay or neuter the cats and give them basic vaccinations. Community members return each cat to the area from which it came that same day. Our TNVR program helps keep the feral cat population from growing beyond what the local environment can support.

## Will Operate for Lodging

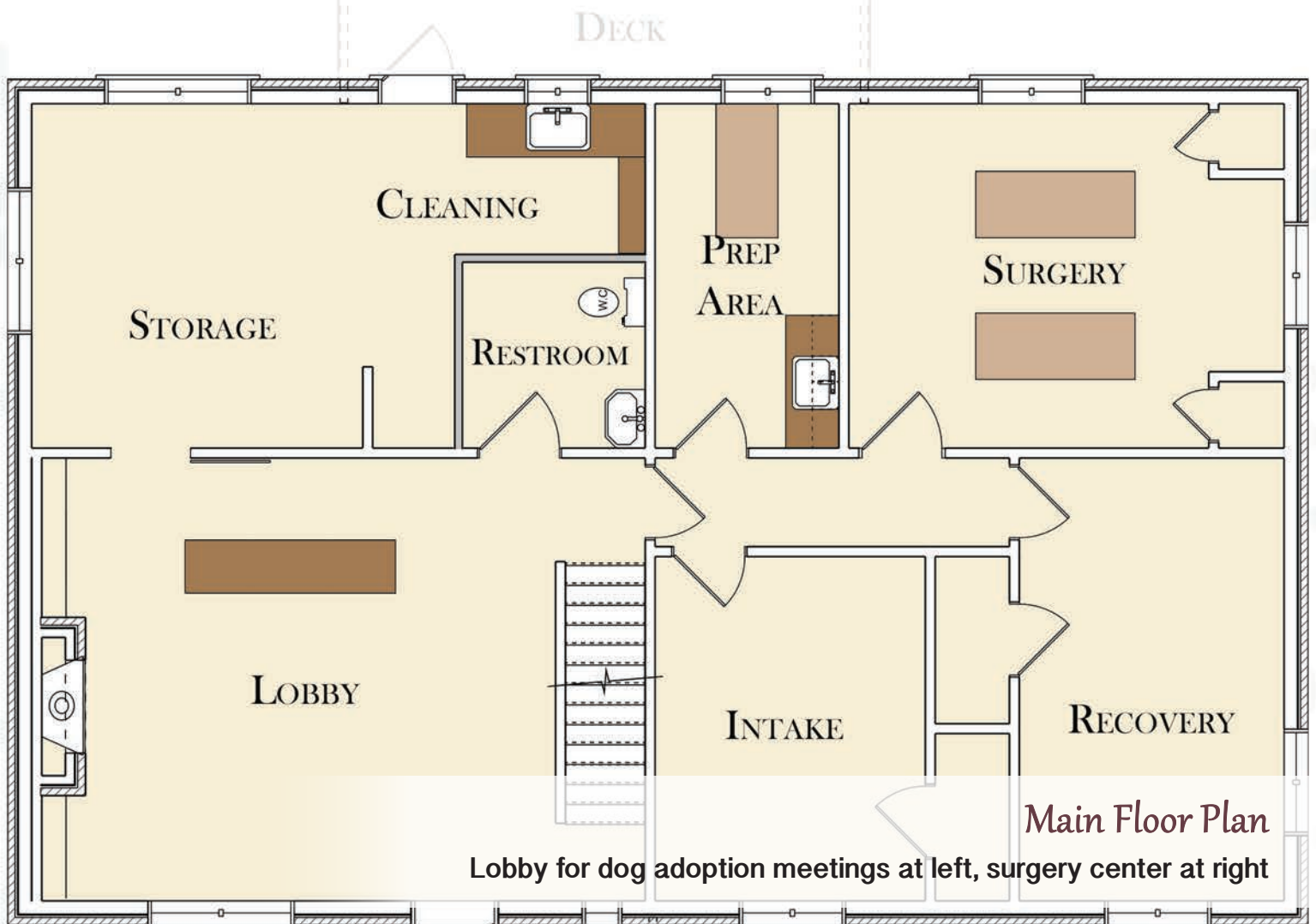
The building's second floor will be converted into a studio apartment. Practicing and student veterinarians volunteer for us so they can learn high-volume spay/neuter surgical techniques from our staff. Providing an inexpensive place to stay will help attract more volunteer vets, saving us money and preventing feral cat overpopulation.

### \$500,000 and higher – Name the Building

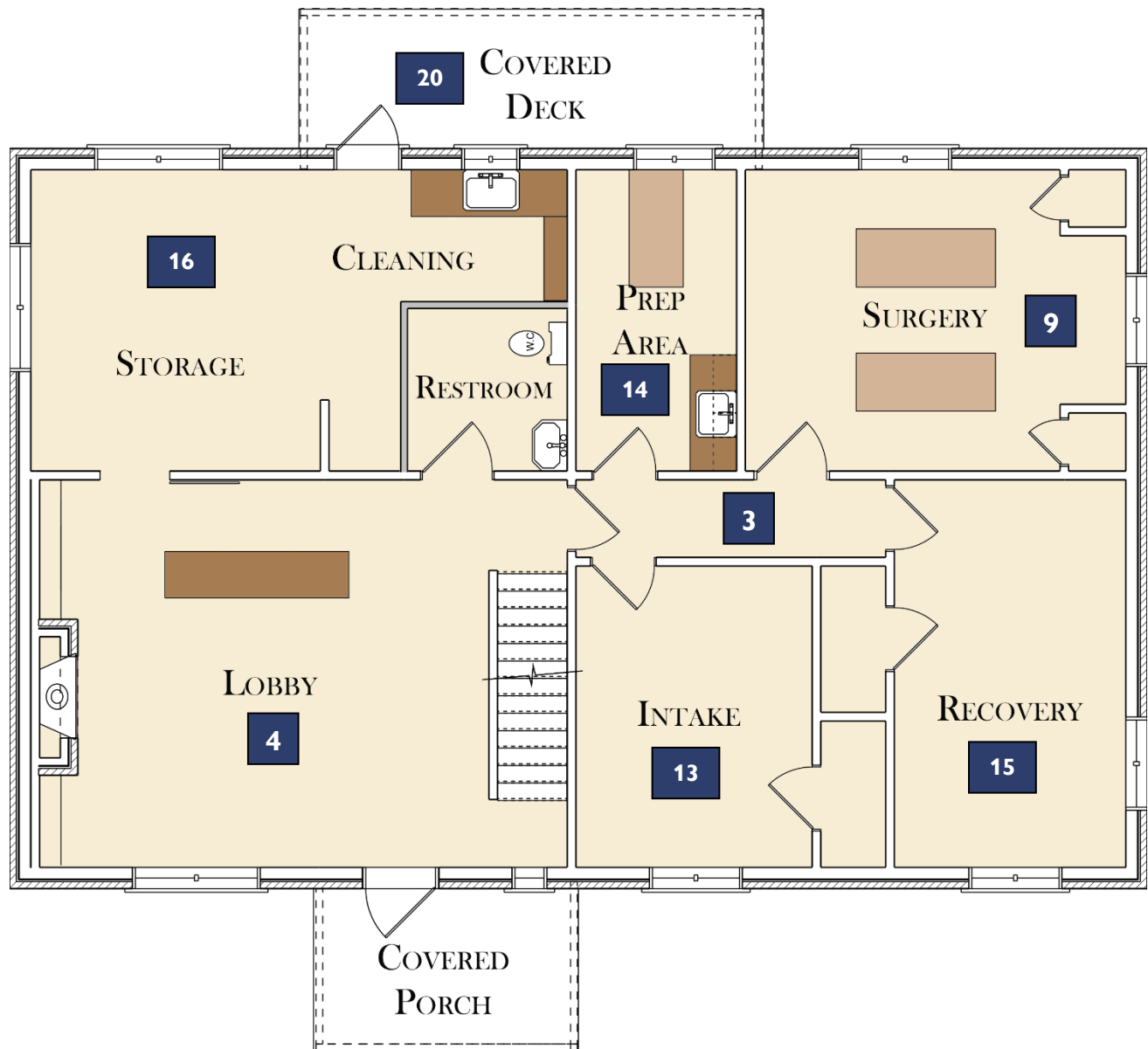

## FREQUENTLY ASKED QUESTIONS

### ***Forever Homes for Dogs Campaign***

#### WHY CAN'T PET PANTRY DO DOG ADOPTIONS FROM ITS CURRENT HOME?

Any facility that houses dogs overnight must be properly zoned and licensed for this use. Our Millersville Road building is not. We have only been able to accept stray or surrendered dogs when we have a foster family available to take them home immediately. The building at 2120 Columbia Avenue was previously a veterinary hospital and then a dog grooming and boarding business. It fits our needs perfectly! We can house up to six dogs at a time until they find their forever home.

#### WILL MY GIFT TO THE CAMPAIGN BE TAX DEDUCTIBLE?

Yes. Pet Pantry of Lancaster County is a tax-exempt organization under Section 501(c)(3). Please consult your financial advisor for guidance regarding your individual circumstances and to determine the most tax effective manner in which to make your gift.

#### LANCASTER HAS MULTIPLE DOG AND CAT RESCUE ORGANIZATIONS, SOME OF WHICH SEEM TO COME AND GO. WHAT MAKES PET PANTRY DIFFERENT, SUCCESSFUL, AND MORE HUMANE?

Pet Pantry was established in Lancaster County, and we focus solely on the animals within our community. Every dollar donated to us goes to work locally, not to a larger organization. We focus on the needs of the animals, so we are a certified Fear Free®, no-kill shelter. We do not euthanize an animal because it's taking a long time to find it a forever home or we need the space for a new arrival. For the past 12 years, our growth has been careful and strategic, and we approach every decision with an eye toward its impact on our sustainable business model. We are honored to have been voted the #1 Place to Adopt/Buy an Animal in the LNP Readers' Choice Awards two years running.

#### OVER HOW MANY YEARS MAY I PAY MY PLEDGE?

We are offering pledge periods of up to five years. Donors will receive pledge payment reminders annually.

#### WHY IS IT IMPORTANT TO BUILD A SURGERY CENTER FOR FERAL CATS?

Although we can spay/neuter feral cats in our current building, performing the procedures down the street will protect our adoptable cats from accidental exposure to communicable diseases. Our staff and volunteer veterinarians will be able to perform these procedures daily instead of once a week (based on operating room availability), helping to keep Lancaster's feral cat population under control. Fewer feral cats will have to face starvation, disease, extreme heat and cold, worms, fleas, and cruelty from humans on a daily basis.

## WILL PET PANTRY OFFER “NAMING” OPPORTUNITIES IN THIS CAMPAIGN? WHAT DONOR RECOGNITION IS PLANNED?

There are a few space naming opportunities in the new facility for those who wish to make gifts in honor or in memory of someone. Campaign leaders have an updated list of spaces that are available for naming and the minimum gift required for each opportunity. All donors contributing \$5,000 or more (payable over as many as five years, if desired) will be recognized on a permanent donor wall inside the new facility on Columbia Avenue. Please know that gifts of any size will be gratefully accepted and acknowledged fully.

## CAN I MAKE A PLANNED GIFT AND HAVE IT COUNT TOWARD THE CAMPAIGN?

New and increased planned gifts will be gladly accepted and celebrated as part of the *Forever Homes for Dogs* Campaign. If you are age 72 or older (or will turn 72 before the campaign concludes in 2025), an irrevocable planned gift can be counted toward the campaign goal.

## CAN I MAKE A GIFT OF MATERIALS, LABOR, OR EQUIPMENT (GIFTS-IN- KIND)?

Yes, in many cases, subject to the particular project needs, Pet Pantry would very much appreciate gifts of material, labor, technology, and furnishings in addition to outright monetary gifts. Some proposed projects could be completed with donated materials, labor, equipment, and technology. ## I'M NOT SURE I CAN SUPPORT THIS CAMPAIGN AND MAINTAIN MY CURRENT LEVEL OF GIVING. WHICH SHOULD I PRIORITIZE?

Much as we would love for everyone to participate in the *Forever Homes for Dogs* Campaign, we know that financial resources vary among our supporters. It is important for Pet Pantry's fiscal health that annual donors continue their regular giving. We suggest that any support of the *Forever Homes for Dogs* Campaign be above and beyond your annual contribution. A few extra dollars per month for five years can really add up!

**A MULTI-YEAR PLEDGE**

Donor(s) may choose to make their campaign gifts payable over a period of up to five years with the completion of a written pledge form.

**A GIFT OF SECURITIES**

Individual supporters may own stocks, bonds, or mutual funds that have appreciated beyond their original cost and may consider making their campaign gift with these appreciated securities. Such a gift may be a tax efficient way to support the *Forever Homes for Dogs Campaign*. **IRA CHARITABLE ROLLOVER / QUALIFIED CHARITABLE DISTRIBUTION**

Donors age 70½ years or older may consider making a direct transfer from their IRA accounts to Pet Pantry of Lancaster County, Inc. The basic details and restrictions to take advantage of this opportunity to support this campaign appear below:

- You must be 70½ or older when you make your gift, and the gift must be made from an IRA. No other retirement plans (such as 401k, 403b, or SEP accounts) qualify.
- Although the distribution will be free from income tax, it will not generate an income tax charitable deduction.
- This giving option may be of particular benefit for those who do not itemize deductions.

**PLANNED GIFTS**

There are opportunities for individual contributors to support Pet Pantry through a planned or estate-related gift. Such gifts will be used to grow the organization's endowment, which generates income to support the needs of animals year after year—forever. Depending on your situation, planned gifts may or may not be able to count toward the *Forever Homes for Dogs Campaign's* \$1.5 million goal, but they may enable you to secure a specific naming opportunity.
